





Hong Kong Background:

- US Fruit, Vegetable, Nut Exports: \$1.3 billion
- New national MRL list August
 1, 2014
- Established 8,300 Hong Kong National MRLs
- Based on Codex and other MRLs





Hong Kong MRL Policies:

- Hong Kong Centre for Food Safety
- Has a system in place for est'ing new MRLs
- Committed to adopting Codex MRLs
- No new MRLs since August 1, 2014. MRLs pending.
- Political Controversy





Hong Kong Residue Testing Policies:

- CFR Food Alerts Review: 2015-2016: No MRL violations cited, contaminants and other issues only
- Testing and enforcement: Do test: reserve right to test anything
- Only test against existing MRLs
- Actions taken if violation

The Future of Hong Kong MRLs

- Need many more MRLs
- Need to resolve political issues to advance MRL solutions
- Adopt Codex MRLs and allow for additional applications





Philippine Market Background

- Population: 107.6 million
- Per Capita Income: \$2,765, but growing Middle Class
- Manila, Cebu, Davao
- Robust economy (6% growth)
- Steady growth in the country's retail, foodservice and food processing sectors
- Consumer familiarity with American brands





Philippine Market Background

- US Agriculture Exports; \$2.7 billion. (largest supplier)
- US Fruit, Vegetable, Nut Exports: \$169 million
- Fresh Fruit and Veg. Tariffs: Average 7-15% applied

Philippine MRL Policies


- Fertilizer and Pesticide Authority manages domestic registrations
- Does maintain national Philippine MRLs
- Published in hard copy. Not online
- Work with registrants and labs for registration
- Consider Codex, ASEAN MRLs as establish Philippine MRLs





Philippine MRL Policies

- Philippine Major Tropical Fruit Exporter: Bananas, Mango
- Greatest Concern: Export Markets: especially Japan, Korea, Taiwan, China
- Have had export issues
- Work with companies to ensure MRL compliance
- Lab testing of exports
